All that certain tract of parcel of land, situate, lying and being in Cleveland Township, Greenville County, South Carolina, near the Beech Highway, containing one hundred and four (104) acres, more or less, being that part of the property of Pioneer Park as is shown on a plat thereof recorded in the R.
