All that tract of land in Caluda Township, State and  
 contains acreage being on Pinconneke Road, about seventeen  
 acres in Greenville S.C. bounded by lands of Joe  
 Trainwell, Mrs Taylor, David Johnson, George Johnson  
 and others, containing 128 acres more or less, originally  
 consisting of two tracts of 78 acres (being same conveyed  
 to J. S. Trainwell by D. P. Veener, Master, June 22, 1897, Vol  
 A. A. 884 and 50 acres, more or less, being same con-  
 veyed to J. S. Trainwell by Furman University Dec 24,  
 1904, Vol N. N. N. - 442. Said two tracts are the same  
 conveyed to a Justice by J. A. Ruskin, Vol 32, 293,  
 and by said Justice to C. L. Wright, Vol 74-54 saving  
 and excepting from the conveyance the following  
 tract to wit, one of 7 acres more or less, conveyed  
 by C. L. Wright to Mitchell Bryant Nov 22, 1922, Vol 75-  
 552 and one of 20 acres more or less, conveyed by
