J P Massey, all that certain piece, parcel or lot of land in Greenville Township, State and County aforesaid, about three miles Northwest of the City of Greenville, on the East side of the Franklin Road, and being known and designated as lot No 13 A of a survey of property of Leila T. McKinney, made by Captain J. Green, Surveyor, Sept 1926, said plat being recorded in the Office of Greenville County, in Vol. 38, Page 24, and containing the following Metes and Bounds, to wit: Beginning at a stake on the Franklin Road 93.77 feet from corner of said Franklin Road and Edyanda Street, and running thence N. 45° 32' c. 50 feet; thence S. 46° 16' E. 201 feet; thence N. 25° 00' E. 75.2 feet; thence N. 41° 52' W. 158.6 feet to the running corner, and being a portion of the two lots conveyed to me the said Leila T. McKinney by the Colonia Company, June 1st 1926, said deed being recorded in the Office of Greenville County in Book 73, Page 420.
