about eight miles from Mountain Inn and near
Hillside Church, and having the following metes
and bounds:

Bearing on a poplar on west side of a
road, sold ash, and running thence N. $59\frac{1}{2}$ E.
6.34 to a stone at edge of bottom, thence N. $45\frac{1}{2}$ E.
4.6 to a pine on bank of Martins Creek; thence
S. $47\frac{1}{2}$ E. 6.76 S. 55E. 4.54 S. $42\frac{1}{2}$ E. 9.50 S. 33E. 4.00 to stake at
intersection of branch and creek, Anderson corner
25 links from dogwood; thence with old run
of creek to center of Reedy river and up said
river to a stone near large rock on east bank
of river 6.5 links from center of river; thence N.
45E. 16.50 across said hill to a small pine; thence
