Emma O. Eppes, her heirs and assigns forever: all that certain Dist. Parcel or lot of land lying and being in the county and State aforesaid on the line of the city limits of the city of Greenville S.C. being lot no. 16 of Block "B" of the Property of Pendleton Street Realty Association, as shown by Plat recorded in T. M. C. office for Greenville County in Plat Book "A" at Folio 122, 123 dated April 5th, 1906, and revised June 30th, 1909; and having the following metes and bounds to wit: Beginning at a Point on Summer Street corner of lot no. 15 said running thence with line of lot no. 15 N. 74-45 W. one hundred ninety feet and five inches (190'-5 in) to the line of no. 19; thence with the back line of lots numbers 19, 18, 17 & 31-26 E. one hundred sixty-nine feet and five inches (169'-5 in) to a street; thence with the line of said street in an easterly direction sixty-nine feet and eleven inches (69'-11 in) to Summer Street; thence with said Summer Street N. 15-15 E. ninety-four feet and eight and 2/3 inches (94'-8 2/3 in) to the beginning.
