*All that certain piece, parcel and lot of land on Stone Avenue, in the City of Greenville, County and State aforesaid, with the following metes and bounds:*

*Beginning at a stake on Stone Avenue, fifty (50) feet from the southeast corner of Stone Avenue and running thence with said line South 5 1/2 West 150 ft. to property owned formerly by J. C. Gibson, thence along that line and parallel with Stone Avenue forty eight (48) ft. more or less, to the beginning property situated along East line north 5 1/2 East 150 ft. to Stone Avenue, thence along Stone Avenue forty eight (48) ft. more or less to the beginning corner. Also all my right, title and interest of in and to the land, way and right of way, previously described in deed from J. C. Gibson to Annie H. Smith which description is made a part hereof.*

Said mortgage being of record in the R. M. C. Office for Greenville County in Vol. 188 page 3189.*

*As a further consideration the grantor agrees to be responsible for and pay all State, County and City taxes prior to and including the year 1927.*
