Cochran, all that piece, parcel and lot of land situate, lying and being in the County and State aforesaid, on the northeast side of the Augusta Road near the City of Greenville, South Carolina, being a triangular strip adjoining the present residence of the grantee aforesaid named, and having the following meters and bounds, courses and distances: Beginning at a stake on the north east side of the Augusta Road at the southern corner of lot No. 3 now owned by the grantee, and running along said road S. 53° 12' 16" E. twelve and four tenths feet to a stake, the same in a north easterly direction eight, six and four-tenths feet to a stake, on the line of the lot of the said grantee, which stake is ninety one and five-tenths feet north easterly from said road; thence along the line of the said grantee lot S. 59° 34' ninety one and five-tenths feet to the beginning corner.
