Mrs. Bessee Batson:
All that certain piece, parcel or lot of land, in Greenville Township, Greenville County, State of South Carolina, is a subdivision known as Dixie Heights, and being known as Lot Number 55 of the subdivision known as Dixie Heights, a plat of which is of record in the U. S. Office for Greenville County. Said lot having a frontage of 50 feet on Dixie Avenue and running back in parallel lines a distance of 150 feet. The above land shall not be sold, leased or otherwise disposed of to any Negro or any person of Negro descent for a period of thirty (30) years from January 22nd, 1927. The Grantee herein named, agrees to assume one certain note and mortgage in the amount of \$5000 dollars, with interest from January 22, 1928, given by the Dixie Realty Co. Inc. to P. J. Rowley, said Note to bear interest at the rate of 6% and to be paid in three equal annual installments beginning January 22nd, 1929.

The above described land is Lot No. 55, the same conveyed to me by *The Dixie Realty Co.* on the *23rd* day of *February*, 1928, deed recorded in office of Register of Deeds for Greenville County, in Book *Vol. 72*, Page *493*.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appurtenant.

TO HAVE AND TO HOLD all and singular, the premises before mentioned unto the said
