M. C. Office for Greenville County; said lot is a frontage of sixty (60) feet, and runs back a depth of approximately one hundred fifty nine (169) feet to an alley, and is the same lot of land conveyed to Mrs. W. J. Miller by J. S. Patterson, Trustee, by deed dated August 27, 1918, and recorded in Deed Book 8-3, page 146, R. M. C. Office for Greenville County.*
