All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the west side of Lavonia Avenue, said piece being 190 feet North of East North Street, and measuring thence along the West side of Lavonia Avenue N. 21° 00' E. 71.60 feet to an iron pin; thence S. 76° 30' W. 130 feet to an iron pin; thence S. 27° 45' E. 60 feet to an iron pin; thence N. 76° 30' E. 130 feet to the point of beginning being a part of lot No 8 of Rowley Chase plat of which is recorded in the R.
