All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward No. of the City of Greenville, on the west side of Trotter Street, being the eastern half of lot no 12 of a subdivision of land according to a plat recorded in Plat Book A page 151.

Beginning at a corner of an alley and Trotter Street and running thence with Trotter Street N. 1 1/2 E. 50 feet to corner of Lot no 11; thence N. 69 W. 75 feet; thence S. 1 1/2 W. 50 feet; thence S. 69 E. 75 feet to the beginning corner, being the same lot of land conveyed to W. L. Logan by J. M. Fortner, Executor, by deed recorded in Book 58, page 21.
