All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina, on the West side of Conestee Avenue, and being known and designated as lot No. 42 on a plat of South Cherokee Park, which plat is recorded in the A. M. C. Office for Greenville County in Plat Book A at page 130, and having the following course and distances, to wit, which distances, however, are inaccurately set forth on the aforementioned plat as was shown by actual measurement of the lot, the following distances being approximately correct:-

Beginning at an iron pin on the West side of Conestee Avenue, joint corner of lots Nos. 42 and 43, and running thence along the joint line of lots 42 and 43 N. 63° 20' 17 1/2 feet more or less to an iron pin in an alley; thence along said alley N. 27° E. 16 1/2 ft. 8 in. more or less to an iron pin in said alley, joint rear corner of lots Nos. 41 and 42; thence along joint line of lots Nos. 41 and 42 S. 63° E. 17 1/2 - 3/4 feet more or less to an iron pin on the West side of Conestee Avenue, joint corner of lots Nos. 41 and 42; thence along the West side of Conestee Avenue S. 27° W. 64 ft. 8 in. more or less to the point of beginning, being all of lot No. 42 as shown upon the plat above referred to, but having by actual measurement the approximate distances set forth herein, and being a portion of the land conveyed to the grantor herein by Cherokee Land Company by deed dated September 1, 1915 and recorded in the A. M. C. Office for Greenville County in Deed Book 25, at page 96, and also a portion of the land conveyed to the grantor by L. O. Patterson, Trustee by deed dated December 29, 1926 and recorded in the A. M. C. Office for Greenville County in Deed Book 93, page 107.
