Alexander his heirs and assigns forever, all of our undivided right, title and interest in, of and to the following described property, to-wit:

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, and having the following meter, bounds, dimensions to-wit: Beginning at abutment on lower street, corner of lot of Isabel Thomas and running thence westward with the said lower street, fifty (50) feet; thence northward, one hundred (100) feet to a stake, thence eastward, fifty (50) feet to a stake - corner of the said Isabel Thomas lot; thence southward with the line of the said Isabel Thomas lot, one hundred (100) feet to the beginning corner on lower street, this being the same lot of land conveyed to H. C. Alexander by Isabel Thomas by her deed dated September 21, 1917 and recorded in Vol. 75 at page 526, P. M.
