(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Gabrielle Austin and Charley Vandiver Austin.

All claim or interest of any or every kind whatsoever in the Real Estate owned by the said Emma Cannon Austin at her death, being located in the County of Greenville and the County of Spartanburg in the State of South Carolina;

(A, correct copy of the Will herein above referred to is as follows:
" I leave to my husband, William Henry Austin, one thousand dollars (\$1000.00) of the ten thousand dollars (\$10000.00) invested by him,

I leave to my two daughters, Gabrielle Austin and Charley Vandiver Austin, to be equally divided between them, all my other property both personal and Real; including nine thousand dollars (\$9,000.00) of the money invested by my husband. William Henry Austin; all furniture, silver and household goods, my share from the estates of my Father and Mother and all other property.

By two daughters, Gabrielle Austin and Charley Vandiver Austin to be executrices without bond."
