being the same lot conveyed to Eula E. Allen by  
Richard W. Smith, et al by deed dated February  
11, 1918, recorded in P. M. B. Office for Greenville  
County in Vol. 8, Page 73."

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining,  
and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons right-  
fully claiming from, under, or any of them.

his heirs and assigns forever.
