has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Zellie L. Creek  
for his lifetime his or her right and interest  
beginning and ending in the State of South Carolina and  
extending from the City of Greenville, to the corporate limits  
of the City of Greenville, \$10,000.00 and augmented as it  
shall be necessary to pay to Mrs. F. P. Trippins, great or P. E.  
Gatton, Warren & Co., recorded in the P. T. C. Office for  
Greenville County in book No. 7, page 129, and  
paying according to said rate the following rates,  
and so far as I can determine at this time by west  
on E. Main Street 15 cent workshop from north side  
of the street over running there along E. Main Street, N.  
of S.C. St. to intersection with E. Main Street, or 15  
cts. Then moving west on E. Main Street to S.C. St.  
and 15 cts. to the first three No. front doors, to the 12, 18,  
and 24. Then to E. Main Street 15 cent workshop on  
each corner of E. Main and S.C. St. Then to E. Main Street  
across from the first three No. front doors, being  
opposite the Trust Company of the City Greenville & Trust  
Company of Greenville, by Mrs. Martha L. Trippins,  
recorded in the P. T. C. Office for Greenville County in  
book No. 12, page 124. Subject, however, to the restriction  
contained in the deed of the grantee & Trust  
Company of Greenville to Zellie L. Creek, recorded in  
book 195, page 6.  
In part, the consideration for this deed, the Grantee  
having with Grantor to pay the indebtedness of  
Grantor to the Trust Company of Greenville, the
