has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Christine Van Patten,
successor and assigns, all that certain piece
of land lying in Greenville
County, in the State aforesaid, as follows; to
said Plaintiff as lot No. 8 in West M. Perry's sub-
division of a one acre tract of land on Perry
Road, about two miles north of the City of
Greenville. Known as Lane's Lure Park as per
plan recorded in Plat Book C, Page 151, and
described as follows: Beginning at stake on
the eastern edge of Perry Road 741.6 feet from
the southeastern intersection of Mt. Calb Street
and said road, and runneth hence with
said Perry Road S. 17° 45' W. 65 feet; thence with
said road S. 14° 05' W. 65 feet to a stake; thence
S. 74° 26' E. 210 feet to a stake; thence N. 17° 45' E. 130
feet to a stake; thence N. 74° 26' E. 210 feet to
the beginning corner being the same lot
of land conveyed by C. Franklin, Master, on
November 9, 1927, recorded in Deed Book 139, Page 71.

grantee..... hereinabove named, and her

heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
