I do now make and deliver the sealing and delivery of these presents by the grantor, hereinafter named (the receipt whereof is hereby acknowledged), to the present takers, you and yourself, and by these presents does grant, bargain, sell and release unto

the Greenville Hotel Corporation
the tract certain pieces of land or lot of
land on the south side of Sunrice Drive
in Greenville County, and having the fol-
lowing written and bounded, to-wit:
Beginning at an iron nail, lot formerly
known as Johnson's Pasture, and running
thence N. 33° 24' E. 216 ft to a stake; thence
west line to a post 114 ft to a stake; thence
with line of lot no 18 N. 29° 43' E. 190 ft to
sunrice Drive; thence with Sunrice Drive
N. 51° 9' W. 56 ft to curve in road; thence N.
37° 31' W. 56 ft to point of beginning and being
lot no 16. "Section A" Development Caesar's Head

(1.) That the premises shall be used for residential purposes only and that the owner or occupant shall at all times conform to all sanitary and police regulations that may be adopted by the directors of this corporation.

(2.) That the property shall not be sold, leased or rented to any except white persons.

(3.) The Company receives the right to enclose Section A, or any part thereof, of the Company development, this being the section on which the Head and hotel is situated, within a permanent fence and establish and maintain a toll gate or gates at which all persons going in required to pay reasonable admission fees to said Section A provided however that no charge shall be made to the owners of the lots within said enclosure, their families and guests, to all of which terms said parties hereto agree.
