KNOW ALL MEN BY THESE PRESENTS, That Paris Mountain Caesar's Head Companya corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of Ten dollars and other valuable considerations DOLLARS,to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Herbert Lindsay,All that certain piece, parcel and lot of land, situate, lying in the State of South Carolina aforesaid, Cleveland Township, in the North of Sunrise Drive, and having the following metes and bounds, to wit:Beginning at the corner of Sunrise Drive of the lot formerly divided to Herbert Lindsay, and running thence E. 40° E. 196 ft. thence on line from rear of lots 13 to 15, to rear corner of Lindsay lot, thence S. 29° 26' W. 230 ft. with Lindsay line, to point of the beginning, and being a part of the Reservation between lots 13 and 15, Section "A" development of Caesar's Head.

(1) That the premises shall be used for residential purposes only and that the owner or occupant shall at all times conform to all Sanitary and Police regulations that may be adopted by the directors of this Corporation.

(2) That the property shall not be sold, leased or rented to any except white persons.

(3) The "Company" reserves the right to enclose Section A, or any part thereof, of the Company's development, this being the section on which Caesar's Head and hotel is situated, within a permanent fence and establish and maintain a toll gate or gates at which the persons may be required to pay reasonable admission fees to said Section A, provided, however, that no charge shall be made to the owners of the lots within said enclosure, their families and guests, to all of which terms said parties hereto agree.State of South Carolina,
