KNOW ALL MEN BY THESE PRESENTS, That The South Carolina National Bank of Charleston a corporation chartered under the laws of the State of United States of America having its principal place of business at Charleston in the State of S.C. for and in consideration of the sum of Ten & no/100 DOLLARS, and other valuable considerations to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Ellie Owen Fisher

All that certain piece, parcel or lot of land situate and being in the County and State aforesaid, on the south side of Woodvale Avenue, and having the following metes and bounds, to-wit: Beginning at a stake at corner of lot #236 and running thence with Woodvale Avenue N 64-37 E. 70' to a stake; thence S. 25-23 E. 225' to a stake; thence S. 62-30 W. 70' to a stake; thence with line of lot no 236 N. 25-23 W. 225' to the point of beginning, and being lot no 237 of Traylor Park.

- Subject however to the following restrictions: 1. No part of said lot shall be used for any purpose other than a single or multiple residence and outbuildings properly appertaining thereto. 2. No part of said lot shall be occupied by any person of the negro race except in the capacity of a servant. 3. Out buildings properly appertaining to a residence shall be confined to the rear half of the lot upon which they are built unless they shall be integral to the residence to which they appertain. 4. No part of any residence may be built or extend nearer to the front property line of said lot than 3.5 feet. 5. No residence may be built upon any lot fronting upon and bordered on Park Drive which shall have when completed, a reasonable value of less than \$5000 and no residence may be built upon any lots fronting upon Rock Butte Drive,

Woodvale Ave. or Mountain Ave. which shall when completed have a reasonable value of less than \$3,500.00. 6. No spiritous or malt liquors shall ever be manufactured or sold upon said lot. 7. These restrictions are imposed for the benefit of the grantor and may be modified by it when strict modification is desired by him to the best interest of all concerned.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
