(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

L. F. Carson, his heirs and assigns:  
All that certain lot or parcel of land situate in the County and State aforesaid, in the City of Greenville, being known and designated as lot No. 2, Block "C" of subdivision known as Kanata, an incorporation of a plat of same recorded in the office of R. M. C. for Greenville County, and according to said plat having the following metes and bounds:

Beginning at a stake on north side of Oregon Street, 287.7 feet from Augusta Road, at corner of lot No. 1, and running thence along said Oregon Street N. 63-30 E. 66 ft. to stake at corner of lot No. 2; thence along said lot N. 26-50 W. 165 feet to stake at corner of lot No. 11; thence along said lot S. 63-30 W. 59.4 feet to stake; thence S. 25-51 E. 61.5 feet to pipe; thence S. 26-30 E. 103.5 feet to beginning of corner being the same lot conveyed to me by R. L. Wilborn et al, by deed dated Aug. 31, 1927, recorded in the office R. M. C. for Greenville County in Deed Book 124, at page 387.

The grantee herein, by acceptance of this deed, covenants that he will not construct on said lot any surface toilet or closet, but only electric stoves or such other sanitary sewer as may be provided for said granted. This restriction is for benefit and protection of other lots in this subdivision.

The grantee herein assumes and agrees to pay, according to its terms and conditions, a mortgage in the sum of \$400.00 recorded in the office of R. M. C. for Greenville County in mortgage book 146, at page 257; said mortgage being given to Walter Goldsmith.

The grantee also assumes and promises to pay another mortgage in the sum of \$250.00, according to its terms and conditions; said mortgage given to Annie P. Posey, and recorded in said office in mortgage book 133 at page 184.
