KNOW ALL MEN BY THESE PRESENTS, That I, H. E. McCain, of the City  
and County of Greenville

In the State aforesaid,

at and before the sealing of these presents by Sealany Eassy,

in hand paid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Sealany Eassy, her heirs and assigns: All those certain pieces, parcels or lots of land in the County of Greenville, State of South Carolina, and more fully described as follows: Parcel One, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the Town of West Greenville on the corner of Soc (formerly known as Stradley) and Butler (formerly known as Woodside Streets), and having a frontage of 100 feet on Butler Street, and 100 feet on Soc Street, and containing 10,500 square feet. Parcel Two, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being lot no 3 of what is known as Red Top, property formerly owned by J. C. Gower, deceased, and fully described on plat of said property made by H. J. Slaughter, Surveyor, plat recorded in P. M. C. office for Greenville County in Plat Book "page"; Beginning at a stake on Thompson Street, corner of lot no 1, running thence with Thompson Street 8 7/8 E. 41 1/2 feet to corner of lot no 4; thence with line of lot no 4, N. 25 1/2 E. 127 feet to back line of said Red Top property; thence N. 10 3/4 W. 46 1/2 feet to stake, corner of lot no 2, thence in a straight line 18 3/4 feet to the beginning. Parcel Three, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about 1 1/2 miles east of Greenville Courthouse on old Spartanburg Road. Beginning at a stake on the north side of the old Spartanburg Road, 105 feet from Mrs. Bassaway's corner, at corner of lot heretofore conveyed by A. Miles to Lillie E. Miles, and running N. 53 5/8 feet to iron pin; thence N. 45 1/2 E. 438 5/8 feet to iron pin; thence N. 45 1/2 E. 772 feet to iron pin; thence N. 45 1/2 E. 371 feet to iron pin; thence S. 44 1/2 E. 46 1/2 feet to iron pin; thence to Lillie E. Miles, thence with Lillie E. Miles line in a southwesterly direction 420 feet to the beginning corner, containing 4.93 acres, saving and excepting however, lots nos 3 and 5, each fronting 42 feet on old Spartanburg Road, and having a depth of 150 feet, as shown on plat of property of H. E. McCain, made by C. M. Turner Jr., Esq., Nov. 1, 1927. Parcel Four, lot no 5 on lot of property of H. E. McCain, made by C. M. Turner Jr., Esq., Nov. 1, 1927, fronting 42 feet on old Spartanburg Road, with a depth of 150 feet, on which was a one-story frame building. This being the same lot no 5 excepted from Parcel Three of this conveyance. Parcel Five, All that lot of land in the City of Greenville, County and State aforesaid, fronting 35 feet on Calhoun and running back a depth of 70 feet, being the rear half of the lot conveyed by C. M. Turner, Master, to H. E. McCain by deed dated May 4, 1927, recorded in the office for Greenville County in vol 128, page 440. Parcel Six, All that certain lot of land in Greenville Township, County and State aforesaid, being known and designated as lot no 25 of Rickland Hill, and being the same property conveyed to me by Ethelred Realty Corporation by deed dated Oct 30, 1926, recorded in P. M. C. office for Greenville County in vol 132, page 15, reference being made to said deed for a more complete description. As part of the conveyance hereinabove expressed the quantity and description of the property aforesaid for the sum of \$5,500.00, and for the mortgage debt on Parcel One, note and note and note on the sum of \$5,500.00 on Parcels Two and Three, and note on Parcel Five, note and note on the sum of \$5,500.00 on Parcel Six.
