branch of Red Horse Creek, waters of Reedy River

beginning at a point 31 new, on the old  
line, thence N 35° W. 332' stake 31 new, north-  
west of said branch; thence S 23 1/2° W. 377' stake 31  
new on the old line, about one hundred yards  
east of said creek. Bounded from the beginning
