(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Wm. Webster Jr. and *C. M. Snelling Jr.* an undivided
 one half of a certain lot or parcel of land
 situate, lying and being in the City of
 Greenville, County and State aforesaid, at the
 northeast corner of College and Townes Streets,
 and being known and designated as lot no
 19 on a plat recorded in the R. M. C. office for
 Greenville County in Plat Book "E" at page 192
 and bearing according to said plat, the
 following lines and bounds, to-wit:

Beginning at an iron pipe corner of
 Townes and College Streets; thence with College
 Street S. 61-35- E. 49. 2 feet to an iron pipe corner
 of lot no 5; thence with line of said lot N. 20-37
 E. 88 feet to an iron pipe on a ten foot alley,
 thence with said alley N. 61-35- E. 55- feet to an
 iron pipe on Townes Street; thence with said
 street S. 16-41- E. 89 feet to the beginning corner

This deed is subject however to a cer-
 tain wall agreement duly recorded in the
 R. M. C. Office for Greenville County in Deeds
 Book 60, page 277.

 are to assume and pay one half of a certain
 mortgage in the principal sum of \$6,000.00
 executed to the South Eastern Life Insurance
 Company by *L. A. Miles*, and recorded in the
 office of R. M. C. for Greenville County in mort-
 gage Book 187, at page 73.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appur-
 taining.
 TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Wm. Webster Jr.* and *C. M. Snelling Jr.* their
 heirs and assigns, forever.

AND *L. L. Jones* do hereby bind
 heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Wm. Webster Jr. and *C. M. Snelling Jr.* their
 heirs and assigns, against
 every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
