KNOW ALL MEN BY THESE PRESENTS, That

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*J. C. Hayesworth,*  
the said certain lot or parcel of land situated  
lying and being in the City of Greenville, County  
and State aforesaid, at the northwest corner of  
College and St. James Streets and having the follow-  
ing trustee and boundaries, to-wit:

Beginning at a stake, corner of said College  
and St. James Streets and running thence with  
St. James Street N. 15° 42' E. 100 feet to corner of Reeve  
lot; thence with Reeve lot N. 66° 12' E. 100 feet to  
an iron post in Eastern line of De Camp Street;  
thence with said Eastern line of De Camp Street  
S. 15° 42' E. 100 feet to Northeast corner of College and  
De Camp Streets; thence with said College Street  
S. 66° E. 150 feet more or less to the point of begin-  
ning, said lot being composed of the two lots  
conveyed to me by H. A. Towne and C. B. Masten  
as Trustees, by deed recorded in the R. M. C. office  
for Greenville County in Volume 107, at page 33.

As part of the consideration for this deed

dred (\$32,500.00) Dollars mortgage of grantor to

for Greenville County in Real Estate mortgages  
Volume 165, at page 325.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appur-  
tenant.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *J. C. Hayesworth*,

his heirs and assigns, forever.

AND *I* *myself and my* do hereby bind  
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

*J. C. Hayesworth,* *his* heirs and assigns, against  
*my* *myself* and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
