All that piece, parcel or lot of land in the state and County
aforesaid on the west side of Brown Street between Coffee
Street and North Street in the City of Greenville, fronting
said street or feet, more or less, and running back to
within ten feet of the rear end of the two-story brick
building, said depth being ninety feet, more or less, said
building known as the Babb Building leaving a strip
of said ten feet wide between the said lot and the said
building which strip of land may be used in common
by the owners of the land and the said brick building
lot. The land hereby conveyed is bounded on the north
side by the Wright property and on the south side by
the Gibson property. It appears by survey that the lot
of land between Wright property on the north and the
Gibson property on the south has a width of 54 feet,
more or less. Being the same lot of land conveyed to it
by Ella V. Rhodes by deed dated April 21, 1928, and recorded

Ten Thousand Two hundred Eleven and 92/100 (\$10,211.92) dollars
which the grantee assumes; and also to a mortgage given
by E. M. Wharton to Georgia C. Miller, July 1, 1928, for
Six Thousand (\$6,000.00) dollars, recorded in the R. M. C. Office
for Greenville County in Book 176, page 217, upon which
there is due the sum of Four Thousand One Hundred
Eighteen and 44/100 (\$4,118.44) dollars.
Grantee also assumes payment of 1930 taxes.
