(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Cassia L. Cleland, in these two certain lots, pieces,
or parcels of land, situate, lying and being in the
County of Greenville and City of Greenville, at or
near the separate limits of the City of Greenville, known
and designated as Lot number seven (except a strip ten
feet wide north running across the rear or east end
of Lot number seven and heretofore conveyed to Allen
Koser by Title Guaranty and Trust Company, as
Trustee, and Lot number twenty-one (21) on a plat of
Mrs. S. S. Hutchins property made by C. E. Patton, dated March
1924, and recorded in the Office of the Registrar of Deeds
for said County and State in Book
at page 224; the said parcels to be conveyed hereby
being, appearing to said plat, the following: to-wit:-
Lot number seven, beginning at an
iron pipe on the South-east corner of Lot and
Hickins Street; and running thence along Elm Street
a distance of six (6) feet to an iron
pipe on the North-west corner of Lot no. 6; thence with
line of said mentioned Lot no. 6, one hundred and
eighty (180) feet to a stake, ten feet west of said
stake, thence N. 15° W. with line of Alley Koser's strip
and to a stake, on the South side of Hickins Street; thence
with East mentioned street S. 86° 17' 34" W. a little less than one
hundred and sixty-five (165) feet to the beginning corner
second; Lot twenty-one, beginning at an iron pipe
on the East side of Radon Street (three hundred and
sixty and eight-tenths (368.8) feet northward from the
North-west corner of Lot twenty; thence N. 72° 6' one
hundred and forty-nine and ten-tenths (149.2) feet along
line of Lot no. 22 to an iron pipe on joint corner of
lot ten, eleven, twenty and twenty-one; thence N. 15° W.
or East-nine and seven-tenths (89.7) feet to an iron
pipe on the South-east corner of Lot twenty-two; thence with
line of East mentioned Lot no. 22, one hundred forty-
five and ten-tenths (145.2) feet to an iron pipe on East side
Radon Street one hundred and sixty-four and a half
(164.5) feet Southward from Hickins Street; thence along
