(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
 W. H. Burgess, all that certain lot, piece or parcel
 of land, situated, lying and being in the City of
 Greenville, in said State and County, on the
 west side of Main Street, and having the follow-
 ing metes and bounds, to wit: Beginning at a point
 on Main Street, being the northeast corner of lot of James
 F. Hodges' estate, and running thence with line of said said
 lot one hundred and twenty (120) feet to the east line
 of an eleven (11) foot alley, thence with said alley twenty-five (25)
 feet to a cross piece, thence a line parallel with the first
 line above described, one hundred and twenty (120) feet to
 Main Street, thence with said Main Street twenty-five (25)
 feet to the beginning corner, bounded on the back (129 feet)
 by lot of James F. Hodges' estate; on the west (25 feet) by a
 twelve (12) foot alley; on the north (25 feet) by lot of W. H. Burgess;
 and on the east (25 feet) by the west side of Main Street;
 containing three thousand (3000) square feet, more or less, and
 being the same lot conveyed to me by J. G. Doster, by Deed
 bearing date of April 19th, 1900 and recorded in R. M. B. Office
 for said State and County on October 4th, 1900, in Deed
