Beginning at a stake on Dixon's Alley corner of lot now owned by Robert Dixon colored, and running thence in a general southwesterly direction along the line of said Robert Dixon a distance of 150 feet to a stake; thence in a general northwesterly direction parallel with Dixon's Alley 40 feet to a stake; thence in a general northeasterly direction 150 feet to a stake on Dixon's Alley; thence with said Dixon's Alley in a general southeasterly direction 40 feet to the beginning corner, all being the same lot of land conveyed to me by *H.
