the tract of land situated, lying and being in Austin Township, County and State aforesaid, and on both sides of the said Georgia Road, near the town of Greenville, in a long narrow fully described as follows:

Beginning at a stone in branch at the crossing of the old road and running thence N. 71° 18' 27" E. to stone; thence S. 14° 18' 13" E. to stone 3 1/2 m.; thence S. 53° E. to stone in branch; thence up the branch 5.00 to fork of branch; thence up meanderings of the Eastern branch 2.97 to iron post; thence S. 39° 16' 7.54 along branch to iron post 3 1/2 m. thence N. 11° 18' 13" E. to iron post 3 1/2 m.; thence N. 84° 1/2 E. 3.17 to a stone in branch; thence down the branch 4.39 to the beginning corner and containing twenty-three and one half acres, more or less, and being the same land conveyed to me, J. M. Alexander by deed of Lula Putman dated Dec 13th, 1918, and recorded in office of P. W. C. in Vol 34 at page 101.
