"All those two certain pieces, parcels and lots of land, situate, lying and being in the State of South Carolina, and County and Township of Greenville near Woodsides Mill, on the new cut road, and being known and designated as lots nine and ten & 9 and 10 on the Plat of a Subdivision known as "East Burn mit View", which Plat is recorded in Plat Book A, Page 589, said lots having a frontage of Fifty (50) feet each on the new cut road; these being the same conveyed to A.
