on the Easley Bridge Road about 4 miles from Greenville Court House and having the following metes and bounds, to-wit:

Beginning on the north side of the Easley Bridge Road corner of David Burns' land thence with David Burns land N. 25° 44' E. 1200 feet to a rock; thence S. 47° 44' W. 1259 feet to said road; thence N. W. 459 feet to beginning corner containing 6-4¹⁰⁰ acres, more or less, and being the same tract conveyed to me by A. J.
