bound outside the city limits of Greenville, I do know,  
such delineated as a portion of Lot No. 10 of the  
1st Addition to the Village of Michalton according to a  
plan recorded in Plat Book 6 at page 96 and  
bearing the following notes and legends to-wit:  
Beginning at an iron post on the West side  
of an unnamed road or street at a point fifty  
feet further up the said road from Corner of Lot No.
