in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *Henry Brigggs*

all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina,

on Alexander Street, just outside the corporate limits of the City of Greenville, known as lots Nos. 1, 2, 3, and 4 of a plat of property of Canton Street, each of said lots having the following courses and distances according to survey and plat made January 14, 1927, by Dalton W. Lewis, Engineer, said plat recorded in Plat Book, page 14. Lot No. 1: Beginning at an iron pin, corner of lot of Samuel Brigggs, of the south side of Alexander St., and running thence with Brigggs' line, S. 32-30 E. 83 feet to iron pin; thence N. 07-50 E. 71 feet to iron pin, corner of No. 2; thence with line of said lot N. 32-30 E. 83 feet to iron pin on Alexander Street; thence with Alexander Street S. 57-30 W. 71 feet to the beginning.

Lot No. 2: Beginning at an iron pin on the south side of Alexander Street, 71 feet east from Samuel Brigggs' corner of lot No. 1 and running thence with line of lot No. 1 S. 32-30 E. 83 feet to iron pin; thence N. 07-50 E. 71 feet to iron pin, corner of lot No. 3; thence with line of lot No. 3 N. 32-30 E. 83 feet to iron pin on Alexander Street; thence with Alexander Street S. 57-30 W. 42 feet to the beginning. Lot No. 3: Beginning at an iron pin on the south side of Alexander Street, corner of lot No. 2 (which pin is 113 feet east of Samuel Brigggs' corner) and running thence with line of lot No. 2 S. 32-30 E. 83 feet to iron pin; thence N. 07-50 E. 71 feet to iron pin, corner of lot No. 4; thence with line of said lot N. 32-30 E. 83 feet to iron pin on Alexander Street; thence with Alexander Street S. 57-30 W. 43 feet to the beginning.

Lot No. 4: Beginning at an iron pin on the south side of Alexander Street, corner of lot No. 3 (which pin is 156 feet east of Samuel Brigggs' corner) and running thence with line of lot No. 3 S. 32-30 E. 83 feet to iron pin; thence N. 07-50 E. 71 feet to iron pin, corner of lot No. 5; thence with line of said lot N. 32-30 E. 83 feet to iron pin on Alexander Street; thence with said Street S. 57-30 W. 46 feet to the beginning.

The above described land is a portion of the same conveyed to me by *Baslow West* on the *12th* day of *January*, 192*7*, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book *Page* *1927*.

heirs and assigns, against *me* and *my* heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
