all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

being in the City of Greenville on the east side of Pettigrew Street and being Lot number One (1) as shown by plat made by H. D. Nevers, dated November 6, 1921 and said is part of the subdivision made by the said Nevers for H. M. Buffin and having the following metes and bounds description to wit:

Beginning at the northeast intersection of said Pettigrew Street and Whitsell Street and running thence North sixteen degrees East sixty-six feet, thence North Eighty-two degrees thirty-seven minutes East Seventy-seven and eleven tenths feet, thence South twenty-four degrees West forty-seven feet to Whitsell Street, thence along Whitsell Street South Seventy-seven degrees thirty-five minutes West ninety-five and six-tenths feet to the beginning corner;
