Dollars.paid by *The Carolina Loan and Trust Company*in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *The Carolina Loan and Trust Company, its successors*

all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina.

Just outside the City of Greenville, in the County and State aforesaid, on the south east side of Grove Road, being lot No. 3 in Block 7 of the O. P. Miller property, according to Survey made by R. E. Dalton, Surveyor, recorded in office of R. M. C. for Greenville County in Plat Book 6, page 176, also having the following metes and bounds, to-wit:

"Beginning at an iron pipe on Grove Road joint corner of lots Nos. 3 and 4 and running thence N. 60-07 W. 112-4 feet to an iron pipe in rear line of lot 3 and 4; thence N. 20-04 E. 50 feet to an iron pipe joint corner of lots 2 and 3; thence N. 70-11 W. 111.8 feet to an iron pipe on Grove Road; thence N. 18-37 E. 24.2 feet; thence N. 21-38 E. 43.8 feet to the beginning corner, and being the same lot conveyed to J. L. Hayes by Anne M. Moore by deed dated December 23, 1925, and recorded in the R. M. C. Office for Greenville County Deed Book 105, page 541." The consideration of \$4,500. expressed represents the mortgage to The Carolina Loan and Trust Company recorded in Mortgage Book 151, page 118, and it is agreed that said mortgage may be held open to protect the title of the company against intervening encumbrances.
