to me said by *The Carolina Loan and Trust Company*

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release,  
unto the said *The Carolina Loan and Trust Company, its successors and assigns*  
all that piece, parcel or part of land in *Greenville* Township, Greenville County, State of South Carolina.

*And described as follows, being lot No. 14 of Block "2" Plat 1377-5, page 41, (P. M. Co. Office for Greenville County) of Shapiro Skiving Land Company, having the following boundaries to wit:  
Beginning on the North side of Rose Avenue, at the corner of lot No. 15; thence running with lot No. 15, N. 22 W. 150 feet to E. line of lots Nos. 5 and 6; thence N. 88 E. 50 feet to corner of lots Nos. 7 and 6; thence S. 2 E. 150 feet to Rose Avenue; thence with Rose Avenue S. 88 W. 50 feet to the beginning corner.  
This is the same land conveyed to the said *Lee H. Floyd* by *L. P. Eison*, June 30, 1930.  
It is understood and agreed that this deed is made to the grantee in consideration of the mortgage indebtedness to it, but that the mortgage shall be held open only for the protection of the title against intervening lien claimants and no personal liability on account thereof shall obtain.  
Further agreed that immediate possession is hereby given to the grantee with right to collect all rents and that this deed is absolute in intent as well as form.*

The above described land is the same conveyed to me by *A. P. Eison* on the *30th* day of *June*, 1930, deed recorded in office of Register of Mease Conveyance for Greenville County, in Book *1980*, Page *1*.  
TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining,  
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said *The Carolina Loan and Trust Company* its successors heirs and assigns forever.

AND *I* do hereby bind *myself and my* heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said *The Carolina Loan and Trust Company, its successors* heirs and assigns, against *me* and *my* heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
