in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said *Mary Ode Littlejohn*,

all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina,

All that parcel or lot of land situate in the subdivision known as "Northgate," in Greenville Township, Greenville County, South Carolina, and known as lot No. 19 of Block 3 of the lands of the Utopian Developing Company, on plat of W. M. Fulman, Jr., G. C., made June, 1926, Recorded in the Office for Greenville County in Volume "G," page 135-136.

This lot is sold subject to the following building restrictions. The property herein conveyed or any part thereof shall never be sold, rented or otherwise disposed of to any person having any percentage of negro blood. The property shall not be used at any time for any business purpose or for anything which would constitute a nuisance. The property herein conveyed shall never, at any time, be re-cut or sub-divided so as to face in any other direction than as shown on the plat of the same.

No building shall ever be erected upon the lot wider than 40 feet to the present line of the street upon which it faces.

No buildings other than outbuildings appertaining to a dwelling) costing less than twice the cost of the lot shall be erected upon the said property.

The lot is sold subject to an easement of two (2') feet parallel with the rear line of said lot, for the purpose of placing sewerage lines, telephone and electric light poles or cables, for the use of the lot and other lots in said subdivision, with the right of entry for the purpose of erecting, renewing or repairing of said utilities.

It is understood and agreed that Mary Ode Littlejohn assumes and agrees to pay the mortgage on the lot, and all taxes and other liens thereon, except the taxes for 1932 which the grantor agrees to pay.

The above described land is *Utopian developing* the same conveyed to me by *Wm. H. Littlejohn* on the 26th day of March, 1926, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 138, Page 15.
TO HAVE AND TO HOLD, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, to have and to hold, all and singular, the premises before mentioned unto the said *Mary Ode Littlejohn*, her heirs and assigns forever.

AND I, myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said *Mary Ode Littlejohn*, her heirs and assigns, against me and my heirs and assigns, against person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
