Together with, all and singular, the rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident to or appertaining, TO HAVE AND TO HOLD, all and singular, the said right of way and the rights hereinbefore granted, unto the said State Highway Commission, its successors and assigns, so long as the same shall be used as part of the highway system of this State or Nation.
