A. John S. Hill, of said county and State,  
in consideration of the sum of One hundred and no  
Dollars (\$100.) to me in hand paid by Carolina Power  
and Light Company, the receipt whereof hereby  
acknowledged, does hereby grant unto the said  
Carolina Power & Light Company its successors,  
lessees and assigns, the permanent right, privilege,  
and easement to go over and upon (that tract of  
land) of land in Cleveland Township, Cleveland  
School District, in said county and of state bound-  
ed North by lands of Newbold and Mayes Cleveland  
land, East by lands of " " Cleveland  
South by lands of Carl Johnson, West by lands  
of Newbold and Mayes Cleveland, and its con-  
struct and maintain in, upon and through said  
premises, in a proper manner, with poles, towers,  
wires and other necessary apparatus and appliances,  
two lines of structures of wood or steel for the  
purpose of transmitting power by electricity, and  
supporting telephone wires, together with the right  
at all times to enter upon said premises for the  
purpose of inspecting said lines and making  
necessary repairs and alterations theron, a center  
line for the erection of the first of said two  
lines of structures, holding down heretofore sur-  
veyed, marked and staked but on the premises,  
and the center line for the second of said  
two lines of structures to be located fifty-feet  
therefrom or less on the West side thereof and  
to run approximately parallel thereto. Said lines  
to be constructed of either towers or poles which  
may be changed from one to the other, from  
time to time at the option of the grantee; with  
the right to make such changes, alterations and  
substitutions in said lines of structures from  
time to time as the grantee herein may deem  
advisable or expedient, together with the right  
to keep said right-of-way clear of all structures  
and underground utilities between said lines and  
for the space of twenty-five feet on each side  
hereof with the further right to cut away  
and keep clear of said lines and vines  
all trees and other obstructions that might  
in any way endanger the proper operation  
of same. It is agreed between the parties  
hereto that the poles, towers, wires, and

other apparatus and appurtenances hereunder  
shall stand remain the property of the company  
and may be removed by the company at any  
time. The grantee may at first build only one of  
said lines of structures, without waiving its  
right thereafter to build the other as and if it deems  
it does.
