E. Dalton, Engg and recorded in the R. M. C. Office for the State and County aforesaid in Plat Book "C" at page 290 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the National Highway at corner of Tract No. 2 and running thence with Tract No. 2, S. 19-07 E. 467 feet to a pipe in line of Boling property; thence with line of Boling property, S. 86-10 W. 180 feet to a spring; thence S. 12-31 E. 261.3 feet to a pine; thence S. 8-51 E. 23.8 feet to an iron pin, corner of tract No. 16; thence with lines of tract No. 16, N. 89-34 W. 81 feet to a pine in line of property now or formerly owned by J. D.
