And having the following metes and bounds:  
Beginning at a stone Northwest 1/4 of farm and is also border of the Poole farm, and running thence S. 28 1/2 W. 31.50 Chs. to a stake in old road; thence along old road S. 50 E. 5.17 Chs. to angle in road; thence S. 53 E. 21.50 Chs. to angle in road; thence S 52 E. 3.00 Chs to angle in road; thence S. 69 1/2 E. 2.45 Chs to a stake; thence N. 29 1/2 E. 9.43 Chs. to a stake; thence S. 61 1/2 - 2.84 Chs. to stake in branch; thence up and with the meanderings of said branch as a line 19.56 to an iron pin in the clutch of branch; thence N. 54 W. 13.44 Chs to the beginning corner containing fifty acres, more or less, and adjoining lands of S.
