Fossett, All our right, title and interest in and to all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

and being on the Old Rutherford Road and containing 19.29 acres, more or less, and having the following metes and bounds according to a plat made by C. M. Furman Jr., Birth Day February 24, 1930.

Beginning at an iron pin on the Rutherford Road and running thence with said road, N. 72-03 E. 346 feet to a pin in said road, thence continuing with said road N. 72-19 E. 394.7 feet to an iron pin in said road, thence N. 46-44 E. 107.3 feet to the Greenville County Property, thence with line of said property N. 60-28 E. 194.3 feet to an iron pin, thence S. 58-54 E. 327 feet to an iron pin, thence S. 28-48 E. 63.3 feet to the beginning corner being the same tract of land conveyed to B.
