demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 12th day of July 1929 and such proceedings were had therein as resulted in a Decree

NOW, therefore, Know all Men by these Presents, That I, E. Inman Master in and for the County of Greenville, aforesaid, in consideration of the sum of Ten Thousand (\$10,000.00) to me paid by the said Mrs Fannie C. Norwood

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

Mrs. Fannie C. Norwood, the following described real estate.

All that certain lot of land in Ward Three of the City of Greenville, County and State aforesaid, beginning at a pin on the south side of West Washington Street distant forty feet west from the northeast corner of the property of C. S. James, the corner of the lot conveyed by J. S. Norwood to H. Carroll McDaniel, and running thence in a southerly direction with the line of the McDaniel lot, 95 feet to a pin, thence in a westerly direction parallel with the south side of West Washington Street, 20 1/2 feet to the line now or formerly of James McPherson and others; thence in a northerly direction on line parallel with McDaniel's line 95 feet to West Washington Street; thence in an easterly direction with said West Washington Street 20 1/2 feet to the beginning corner being the same lot of land conveyed to C. S. James by John L. Williams by deed dated Nov 26, 1921, recorded in Vol. 79 page 230, B.M.C. Office for Greenville County, and conveyed by C. S. James to Fannie C. Norwood, as Trustee, by deed dated July 1, 1922, recorded in said office in Vol. 85, page 85, and reconveyed to C. S. James by Fannie C.
