the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

Mechanics Building and Loan Association, a Corporation, the following described real estate: "All that certain piece, parcel and lot of land lying and being in Greenville County, in the State aforesaid, as follows, to wit: Known as lot No. 57 on plat of lands of H. B. Botis made by R. E. Patton, Engineer, and recorded in office of the R. M.
