"All that certain tract of land in Fairview Township, County of Greenville, State of S.C., containing 10 acres, more or less, about one mile west of the Town of Fountain Inn and on the north side of the highway leading from Fountain Inn to Greenville and having the following metes and bounds and courses and distances as shown in blue print and plat made by C. M. Norman, Jr., C. B. January 16, 1930: Beginning at a stone in the Greenville road, panel 8 and corner angle running thence along the line of the Concrete Highway N. 63 W. 10 chs. to a stone on said road; thence N. 38 E. 6. 10 chs. to stone 3 1/2 chs. thence S. 63 E. 10 chs. to stone; thence S. 38 E. 10 chs. to the beginning corner, bounded by lands of R.
