demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 18th day of July 1930 and such proceedings were had therein as resulted in a Decree

NOW, therefore, Know all Men by these Presents, That I, E. Inman Master in and for the County of Greenville, aforesaid, in consideration of the sum of Twenty Five Hundred (\$25.00.00) Dollars, to me paid by the said Lyda Pearl Henson

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

Lyda Pearl Henson, the following described real estate: All that tract of land in Highland Township, Greenville County, South Carolina, and known and designated as Lot No. 5 of the property of the J. S. Henson Estate, according to a subdivision and plat of same made by J. C. Mohrman, in March, 1930, containing 60.22 acres, more or less and having the following metes and bounds and courses and distances as shown by said plat to wit: Beginning at an iron pin at the southeast corner of Lot No. 3 and running thence N. 22.5.00 to a pin, thence N. 64.5.21.11.63 to an iron pin in old road, thence N. 48.30.6.35.60 to a point in line of lot no. 6, thence along the line of this lot N. 41.20.21. 45.80 to a stake, thence along the line of the center land of 62.4.5.21. 6.4.0.70 to a stake, thence continuing along the line of the center land 71.62.30.21. 13.40 to a stake, thence S. 36.52.3.64.20 to a point on small branch, thence S. 84.21.2.75, thence S. 56.21.6.10 to a point in line of lot no. 4, thence along the line of Lot no. 4, S. 84.5.3.50 to stake in branch near large poplar, thence S. 25.21.6.40 to stake in line of lot no. 4, thence S. 48.21.3.90 to stake in line of lot no. 4, thence S. 58.30.21. 9.80 to stake in line of lot no. 4 and at corner of Lot no. 3, thence S. 42.5.12.50 to a stone in line of lot no. 3; thence S. 12.5.13.20 to the beginning.
