WHEREAS, P. M. Goodlett, as Administrator of the Estate of M. A. Goodlett, deceased,

on or about the 19th day of December in the year of our Lord nineteen hundred and twenty-nine exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against S. Sternberg, G. A. Knoblauch, et al.

demanded judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 5th day of December 1929 and such proceedings were had therein as resulted in a Decree

of the said Court whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described be sold by E. Inman Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; and the Master, after having duly advertised the said real estate

for sale by public outcry on the 5th day of January in the year of our Lord nineteen hundred and thirty-one did then openly and publicly, according to the customs of auctions, sell and dispose of the same unto B. B. Balentine and W. L. Balentine

for the sum of Sixty six Hundred (\$6600.00) being at that price the highest bidder therefor.

NOW, therefore, Know all Men by these Presents, That I, E. Inman Master in and for the County of Greenville, aforesaid, in consideration of the sum of Sixty Six Hundred (\$6600.00) Dollars, to me paid by the said B. B. Balentine and W. L. Balentine

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

B. B. Balentine and W. L. Balentine, the following described real estate;

"All those tracts or lots of land in Greenville County, State of South Carolina, as follows:

(a) All that piece, parcel and tract of land situate, lying and being in the County of Greenville, State aforesaid, Reddy River, about one and one-third miles from Greenville Court House, containing 20 acres, more or less, having the following metes and bounds: Beginning at a rock on Reddy River, running thence N. 62 1/2 E. 15.35 to a stone; thence S. 61 1/4 W. 16 to a stone; thence N. 19 W. 10 to a stone; thence S. 68 1/4 W. 9 to a Birch on Reddy River; thence down said river to the beginning corner.

(b) Also, all that piece, parcel or tract of land situate, lying and being in said Greenville County, State aforesaid, containing 13 acres, more or less;

(c) All that piece, parcel and tract of land situate, lying and being in the County of Greenville, State aforesaid, Reddy River about one and one-half miles from Greenville Court House, containing 36 acres, more or less, having the following metes and bounds: Beginning at an iron pin on Reddy River, running thence S. 32 1/4 W. 19 to an iron pin and stone; thence S. 58 E. 3.58 to a stone; thence S. 57 E. 2.03 to a Peraimmon; thence S. 47 1/4 E. 2 to an iron pin; thence S. 44 1/2 E. 7.73 to an iron pin; thence N. 48 1/4 E. 16 to a stone on Reddy River; thence up the river, as the line, to the beginning corner."

heirs and assigns forever.
