L. A. Forresterthe receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto
 the said L. A. Forrester, the following described real estate

"All that certain tract of land in Highland Township, County of Greenville, State of South Carolina, and known and designated as Tract No. A. 1, according to a subdivision and plat of property, belonging to Henry A. Forrester, deceased, made by H. P. Morrow, Surveyor, August 1, 1930, containing 44.25 acres, and having the following metes and bounds, and courses and distances, as shown by said plat, to wit:

Beginning at a stone in line of land of Luther Forrester and just south of the Lewis Chappell Road, and running thence along the Forrester line S. 14° 50' E. 23.12 to stone; thence along line of the L. A.
