all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina.

In the City of Greenville, being known and designated as Lot No. 13 of Block A. of Melville Land Company according to a plat recorded in Plat Book "A" at page 99, and having the following metes and bounds: Beginning on the East side of Sumner Street about 105 feet from the corner of Arlington Avenue at corner of Lot No. 2; thence with Sumner Street S 16-20 W. 52. 37 1/2 feet to corner of Lot No. 4; thence with line of Lot No. 4 S 71-13 E. 194. 86 feet to an alley; thence with the alley N 16-48 E. 51. 17 feet to corner of Lot No. 2; thence with line of Lot No. 2 N 71-13 W. 195. 133 feet to the beginning corner. 
